This communiqué highlights key discussions from the Health Support Services (HSS) Board meeting held on 2 September 2021.

Key Discussion

Following an extensive stakeholder engagement process, and several workshops with Board, Executive, and the Extended Leadership Team, the HSS Strategic Plan 2022-2024 was approved by the Board at the September Board meeting.

Members of the HSS Executive attended the meeting to provide updates on the major programs being delivered across the organisation, including the Human Resource Management Information System (HRMIS), HealthNext, Medical Imaging Replacement Program (MIRP) and, COVID-19 initiatives and VaccinateWA.

Chief Executive's Update

The Minister for Health's *Your Voice in Health* engagement survey results were released to the general public on Thursday 26 August 2021. Further planning work has been conducted by members of the Executive and Senior Leadership Team to inform the actions that need to be taken in response to this year's survey.

The Auditor General publicly released the SafeWA Application Audit on Monday 2 August 2021. This included a series of recommendations for HSS which have either been completed or are in the process of being addressed.

The HealthNext Program has now completed the transition of all applications from the Fujitsu data centres to the new ATOS data centres. HSS has issued the termination notice on the Fujitsu contract (including the early termination of the Murray Street data centre previously discussed with Board). Decommissioning and disconnection of the Fujitsu data centres is expected to be completed by end of September 2021.

The latest Customer Satisfaction Report (CSAT) was positive. Performance in the fourth quarter resulted in a CSAT result of 72 percent, representing an 8 percent improvement on third quarter performance.
