HSS Board COMMUNIQUÉ July 2021 Meeting

This communiqué highlights key discussions from the Health Support Services (HSS) Board meeting held on 1 July 2021.

The HSS Board meeting was streamlined and conducted digitally due to the recent four-day COVID-19 lockdown that was in place across the Perth metropolitan and Peel region.

Key Discussion

Members of the HSS Executive attended the meeting to provide updates on the major programs being delivered across the organisation, including the Human Resource Management Information System (HRMIS), HealthNext, Medical Imaging Replacement Program (MIRP) and, COVID-19 initiatives and VaccinateWA.

The Voluntary Assisted Dying (VAD) project was discussed, including the successful second release of the system coinciding with the legislation coming into force on the day of the Board meeting.

The HSS Transformation and Strategy team working on the Strategic Plan gave an update as to the progress of the plan and confirmed the next steps in the process.

Chief Executive's Update

During May 2021 the WA Premier announced that a \$2.1M COVID PPE Donation would be sent from WA to India, Sri Lanka and Nepal. HSS responded to the announcement and delivered the requested PPE to the airport for onward transporting to the recipient countries.

HSS have been assisting the Department of Health, Department of Justice and Department of Premier and Cabinet in the reading and passing of The Protection of Information (Entry Registration information relating to COVID 19 and other infectious diseases) Bill 2021 which is currently progressing through parliament.

HSS Service Level Agreement (SLA) performance was 79%, against a target of 80% with 27 of 34 KPIs achieved.

As at 18 June 2021 SafeWA has recorded over 250.8 million scan events since contact registration became mandatory on 5 December 2020, with 78.1k business and 1.95M individuals registered.

At the recommendation of the Finance, Risk and Audit Committee, the Board approved the:
