

# Health Support Services Board Communiqué May 2023 Meeting

### **Key Discussion**

The Medical Imaging Replacement Program successfully commissioned the new Enterprise Medical Imaging Solution at Fremantle Hospital and Fiona Stanley Hospital.

The 2023-24 Service Level Agreements (SLAs) between HSS and each customer have been reviewed and endorsed by the Executive Committee and the Board. They will now be finalised and distributed to the Health Service Providers, the Department of Health and all other customers for approval and signing. The focus of the SLAs improvements for 2023-24 has been on continuing to clarify the role of HSS in ICT across the WA health system and adjustments to KPIs associated with ICT and Recruitment.

The Board and Executive Members received an invitation from Western Australian Country Health Services (WACHS) to join the WACHS Board on a regional engagement visit to gain an understanding of the challenges and issues experienced at these locations.

# **Chief Executive's Update**

The Chief Executive highlighted a number of matters including:

- HSS SLA performance was 82% against a target of 80% for March 2023.
   Twenty-eight of 34 KPIs were achieved.
- HSS finalised the Statement of Intent which responds to the Minister for Health Statement of Expectation. This has now been published on the HSS website.
- Current performance across all major ICT programs.
